Open Public Meeting Act: The notice requirements provided for in the Open Public Meetings Act have been satisfied. Notice of this meeting was properly given in the Annual Notice of Meetings which was adopted by the Board of Fire Commissioners, March 7, 2007. Said resolution was transmitted to the Asbury Park Press, filed with the District Clerk and posted in the Cliffwood Fire House.

After the reading of the Open Public Meeting Act, the regular monthly meeting of the Board of Fire Commissioners, Fire District #2, Township of Aberdeen was called to order on Monday, August 1, 2022 at 7:00PM in the Cliffwood Fire House.

The minutes of the previous regular meeting of July 11, 2022 were passed out to all Commissioners and the public. Additions, corrections and/ or deletions will be addressed at the end of the meeting.

Building and Grounds – Comm. Black reports, The cost of painting the exterior of the building is \$18,939 from Mastercraft Painting which includes caulking windows. Comm. DeGiglio excepts the price and Comm. Logan seconds it. All were in favor. Air hose on the tower truck is temporarily fixed. Spoke to someone about adding a part to the sink to get hot water faster. Ed Ziegler made a suggestion about setting up the generator permanently to the building. Will also look into putting a fence around it.

Truck, Radios and Equipment- Comm. DeGiglio reports, Jimmy fixed air hose on 492. Hose Pump and ladder testing will be on 9/8 - 9/9. Still waiting on gear. Comm. Bellamy asked about Ariel fan. It will be looked into when Pat gets better.

Old Business – Comm. DeGiglio asks if 3 vehicles can be taken to Wildwood. 494/ Chief's truck/ Fire Official's truck. All were in favor.

New Business – Comm. Logan reads resolution 2022-8, acceptance of 2020 audit report. Comm. Black makes a motion, Comm. DeGiglio seconds. All were in favor. 3rd qtr install letter was also read.

Insurance – Comm. Logan states, still waiting on removal letter for Faglelman.

Chief's Report – No report

Bureau of Fire Prevention - Comm. Bellamy reads report. \$2,148 was deposited in the Boards account. Ordered helmets for kids today.

Training grounds – Comm. Bellamy states, still waiting on price for spraying from Season's Matter
