March 7, 2022

Open Public Meeting Act: The notice requirements provided for in the Open Public Meetings Act have been satisfied. Notice of this meeting was properly given in the Annual Notice of Meetings which was adopted by the Board of Fire Commissioners, March 7, 2007. Said resolution was transmitted to the Asbury Park Press, filed with the District Clerk and posted in the Cliffwood Fire House.

After the reading of the Open Public Meeting Act, the regular monthly meeting of the Board of Fire Commissioners, Fire District #2, Township of Aberdeen was called to order on Monday, March 7, 2022 at 8:00PM in the Cliffwood Fire House.

The minutes of the previous regular meeting of February 7, 2022 were passed out to all Commissioners and the public. Additions, corrections and/ or deletions will be addressed at the end of the meeting.

Comm. Bellamy swore in Commissioners Steve Gallant and Thomas Logan.

<u>Building and Grounds</u> – Comm. Black reads letter from Dale B who would like to rent the firehouse on 4/2/22 from 1-5pm. Floor Coatings will check out floor repair in about two weeks. Snow blower and salt will be put away. Generator needs looking out. Jim Mullet will measure floors and walls. Carmine called about cleaning the kitchen and floors. Cintas took care of exit signs as well as extinguishers.

<u>Truck, Radios and Equipment-</u>Comm. DeGiglio reports, putting in an order for gear. \$2,903 each. No more than 8 totaling \$23,224. Would like to order shields for guys moving from probation to firefighter. Would like Radios for 491 & 492 for mutual aid. Pricing to follow. Waiting on part for truck 275/490.

<u>Old Business</u> – Comm. Bellamy gave final results of February's Commissioner's election.

New Business – Comm. Bellamy called Allen about facial hair for firefighters and received no reply. The County meeting didn't clarify. Responsibility falls on the firefighters. Will talk to New lawyer about it. Comm. Black talked about explorer program. Comm. Logan read resignation letter from Allen Falk. Term ends 3/31/22. Other letters were read. 1st qtr install to Aberdeen Township, resolutions 2022-3 (meeting time change), 2022-4 (employees/services), 2022-5 (joint districts), and 2022-6 (losap). Comm. DeGiglio makes a motion, Comm. Gallant seconds it. All were in favor. Comm. Bellamy asks if Commissioners were willing to pay for pump class, 5/14-15, 8 hrs. Comm. DeGiglio makes a motion, Comm. Gallant seconds it. Comm. DeGiglio talked about raising the amount for Wildwood and clothing allowance. Will have to see if it's enough in the budget. Comm. Bellamy states that some Commissioners will be attending a town hall meeting on 3/24th and offered to take any questions others may have.
