**RESOLUTION NOTIFYING THE PUBLIC OF THE BOARD'S INTENT TO CONTRACT WITH ROSENBAUER MINNESOTA, LLC, FOR A ROSENBAUER 100' MIDMOUNT TOWER LADDER ON A COMMANDER CHASSIS PURSUANT TO N.J.S.A. 52:34-6.2(B)(3)**

**WHEREAS**, the Board of Fire Commissioners of Fire District No. 2, Township of Aberdeen, County of Monmouth, State of New Jersey, advertised a public meeting wherein it intended to discuss the use of the National Cooperative known as the Houston-Galveston Area Council (HGAC); and

**WHEREAS**, the Board provided the public a mechanism to provide public comment, both prior to and during the public meeting; and

**WHEREAS**, no public comment was received; and

**WHEREAS**, the Board discussed the nature, scope and price of a Rosenbauer 100' Midmount Tower Ladder on a Commander Chassis if purchased through the Houston-Galveston Area Council (HGAC) from Rosenbauer Minnesota, LLC, 5181 260<sup>th</sup> Street, Building #2, Wyoming, Minnesota 55092; and

**WHEREAS**, the Board finds and determines that the District will best be served by contracting with Rosenbauer Minnesota, LLC, through the HGAC program.

**NOW, THEREFORE, BE IT RESOLVED**, by the Board of Fire Commissioners of Fire District No. 2, Township of Aberdeen, County of Monmouth, State of New Jersey, that it provide statutory public notice of its intent to contract with Rosenbauer Minnesota, LLC; and

**BE IT FURTHER RESOLVED**, that the President obtain from Rosenbauer Minnesota, LLC, all necessary and appropriate statutory documents as set forth under The Local Public Contracts Law and other pertinent laws of the State of New Jersey; and

**BE IT FURTHER RESOLVED**, that the within Resolution shall be effective immediately upon passage; and

**BE IT FURTHER RESOLVED**, that any resolution or part of a resolution inconsistent herewith is hereby repealed or otherwise revoked; and

**BE IT FURTHER RESOLVED**, that if any section, paragraph, sentence, clause or phrase in this Resolution is for any reason held or determined to be unconstitutional or invalid, same shall not affect the remainder of this Resolution; and

**BE IT FURTHER RESOLVED**, that notwithstanding anything set forth herein to the contrary, the Board shall be permitted to amend, modify, repeal or otherwise act as to those topics which are the subject of this Resolution provided said acts are consistent with public policy, Board

bylaws, township ordinances, local, state and federal laws and rules and regulations promulgated thereunder; and

**BE IT FURTHER RESOLVED**, that an original signed, conformed and compared copy of this Resolution be accessible and maintained as an official Board record pursuant to and in accordance with the "Open Public Records Act"; N.J.S.A. 47:1A-1, *et seq.* and the "Destruction of Public Records Law (1953)"; N.J.S.A. 47:3-8.1, *et seq.* as set forth by the State of New Jersey Municipal Agency Record Retention Schedule promulgated by the Division of Archives and Record Management.
