Open Public Meeting Act: The notice requirements provided for in the Open Public Meetings Act have been satisfied. Notice of this meeting was properly given in the Annual Notice of Meetings which was adopted by the Board of Fire Commissioners, March 7, 2007. Said resolution was transmitted to the Asbury Park Press, filed with the District Clerk and posted in the Cliffwood Fire House.

After the reading of the Open Public Meeting Act, the regular monthly meeting of the Board of Fire Commissioners, Fire District #2, Township of Aberdeen was called to order on Monday, February 7, 2022 at 8:00PM in the Cliffwood Fire House.

The minutes of the previous regular meeting of January 3, 2021 were passed out to all Commissioners and the public. Additions, corrections and/ or deletions will be addressed at the end of the meeting.

Building and Grounds – Comm. Black states, snowblower fan blade was busted. Dave will still be repairing it. Will look into floor repair in front of 494. Wants to know if heat can be lowered in truck back.

Truck, Radios and Equipment- Comm. DeGiglio reports, 491 will be back tomorrow. Pat looked at 490, will need to get repaired. Dave will do the drawer in back of 492. Next month we'll go over a list of equipment with the officers. 490 had pump gear trouble. Comm. Bellamy asked about the cost of the repair company coming to us. Comm. Gallant asked for an update on the communication system. The mic on Miguel's radio needs to be checked out.

New Business – Comm. Bellamy reads letter from proposed Attorney Joseph Youssouf. Would like to have a face to face with the Attorney. Comm. Gallant spoke of the up coming election.
